THE BOARD WILL THEN DETERMINE IF THE CONFLICT REQUIRES RECUSAL FROM DISCUSSION AND VOTE ON A PARTICULAR ISSUE, RESIGNATION FROM THE BOARD, OR ONLY A NOTATION IN THE BOARD MINUTES.
